Bharati Scheme for Education (BSE)



Andhra Pradesh Brahmin Welfare Corporation (ABC) launched “Bharati Scheme for Education” (BSE) for the academic year 2019-20 to encourage Brahmin students of Andhra Pradesh to continue their education. Under this scheme, a Financial Assistance for the academic year will be granted to the eligible poor Brahmin student applicants.

This scheme is applicable for the Brahmin students of Andhra Pradesh covering all 13 districts, who are studying from 1st Standard to Post Graduation during the academic year 2019-20, as per the specific eligibility criteria provided in the Annexure.

Eligibility Norms:

- The student and his/her parents should belong to Brahmin community and parents should reside in Andhra Pradesh.
- Student should be enrolled in the Praja Sadhikara Survey (PSS).
- Annual Family income of Parents / Guardian should not be more than Rs.3,00,000/- (Rupees Three lakhs only).
- Should be pursuing a regular course in School / College/ Institute / University for the Academic year 2019-20.
- Should have passed in all the subjects till previous year of study (i.e., students who do not have any backlogs in their previous semesters/years are only eligible).
- Should not have availed himself/ herself any amount under any other Government scheme for the same purpose. However, students availing benefit from Archaka Welfare Trust are eligible under this scheme, in addition to the assistance they get from Archaka Welfare Trust.
- Detailed Course wise eligibility criteria is provided in the Annexure to this document.

Application Procedure:

- Eligible students shall register online in the prescribed format through the Corporation's portal (www.andhrabrahmin.ap.gov.in) by providing necessary information.
- The data entered will be validated with the data of Mee Seva, Praja Sadhikara Survey and Civil Supplies departments.
- Applicant should keep the following ready, before proceeding for registration:
 - Aadhar Card of student and parent with address in Andhra Pradesh.
 - White Ration Card / Income certificate Number issued by Mee Seva
 - Integrated Certificate (Caste, Residence and Date of Birth) Number issued by Mee Seva,
- Applicant should upload the scanned copies (in pdf of maximum 1mb size each) of the following documents:
 - Study Certificate from School / College / Institute / University for the Academic Year 2019-20
 - Marks Sheets of all the previous years (starting from SSC).
 - SB Account Pass book in the name of the applicant (Account should be in Andhra bank or SBI. However, for students of PEC & PG outside Andhra Pradesh, account in any Nationalised Bank is acceptable.)

Selection Process

- Short listing, finalisation of applications and sanction of Financial Assistance will be done by the State Level Selection Committee (SLSC) of A.P. Brahmin Welfare Corporation.

Payment of Financial Assistance

- The amount of Financial Assistance granted will be credited through online to the SB Accounts of the students.
- APBWC reserves the right to cancel/withdraw or recover the benefit amount if any of the information provided by the applicant is found to be not true.
